

1991-1992 - Blood Donor Activity was discontinued.

1992-1993 - League designed two new service projects: wheelchair square dancing with Park Lawn Home residents and chaperoning Cabrini School students to volunteer at Peter's Pantry. Medical scholarships of \$1,000 each were awarded to four area High School students and six \$500 grants were given to Continuing Education Students.

1993-1994 - \$2,000 was donated to Manitowoc Historical Society for repair work on Kunze Cabin in Pinecrest Village. Associate members adopted "Project Teddy Bear," a program donating teddy bears to the County Sheriff's Officers for use calming children after frightening experiences.

1994-95 - League played the Christmas Elf role in providing \$1,000 worth of gifts to families at the Domestic Violence Center. A new video replaced the worn out slide show for the pioneer log cabin tour at the Rahr-West Art Museum.

1995-1996 - The Rummage Sale re-located to the Manitowoc County Expo Center and set-up was accomplished in only two weeks. \$1,000 was donated to the Lincoln Park Zoo Expansion Project and \$1,000 was donated to the new Two Rivers Lester Public Library.

1996-97 - "Holiday on the Lakeshore" relocated to the Manitowoc County Expo Center where both attendance and net profit were doubled. \$1,000 was donated to the new Manitowoc Public Library. Organization name was officially changed to "Service League of Manitowoc County".

1997-1998 - Committees were overwhelmed with major modifications to the structure and operation of the organizations. Articles and By-laws were revised following numerous meetings of Actives and Associates.

Once again, "Holiday on the Lakeshore" doubled both attendance (1,500 people) and net profit (\$8,100).

\$10,400 total was donated to community agencies including \$2,000 to the Rahr-West Art Museum, \$1,100 to purchase infant car seats for Holy Family Memorial Hospital, \$1,000 to the Historical Society's heritage Center and \$1,000 to the Holy Family Memorial Hospital Cancer Center.

Nine \$1,000 scholarships were awarded to four continuing education students and five high school graduates.

1998-1999 - Three fundraisers: HOL, Rummage Sale, and the Craft and Garden Show generated a total net profit of nearly \$21,000.

\$11,900 total was donated to community agencies including \$2,250 to the food pantries, \$1,000 to the Domestic Violence Center, \$1,000 to Family Services Lakeshore Lifeline program and \$750 to Kidz Arts Children's Theater.

Ten \$1,000 scholarships were awarded to four continuing education students and six high school graduates.

1999-2000 - Members were consumed with preparing our new cookbook, "Recipes for a new Millennium". One thousand copies were ordered (at a total cost of \$5,000) and each hard-covered book will sell for \$12 per copy.

\$11,800 total was donated to community agencies, including \$2,000 to each of the food pantries, \$1000 to the Domestic Violence Center, \$1,000 to Family Services Lakeshore Lifeline program, \$1,000 to Lincoln Park Zoological Society and \$1,000 to Habitat for Humanity.

Eight \$1,000 scholarships were awarded to three continuing education students and five high school graduates.

2000-2001 - Members volunteered over 350 hours at various community agencies with \$15,750 donated to agencies and \$11,000 in scholarships; three continuing education students and eight high school graduates.

Held two fundraisers, HOL and Spring Rummage Sale; combined totals generated a record net profit of \$22,000. Over \$6,500 was raised on the cookbook and cookie mix gift sets.
